

**PICKEREL LAKE SANITARY DISTRICT**

**ORDINANCE NO. 13**

**AN ORDINANCE ESTABLISHING A SUMP PUMP PERMIT FOR THE DISCHARGE OF WATER FROM BASEMENT AND CRAWL SPACE AREAS INTO THE SANITARY SEWER COLLECTION SYSTEM, THE REGULATION THEREOF AND VIOLATION PENALTIES.**

**BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE PICKEREL LAKE SANITARY DISTRICT, DAY COUNTY, SOUTH DAKOTA, HEREINAFTER DESIGNATED AS BOARD.**

**SECTION I**

**Purpose**

The purpose of this ordinance shall be to establish a Permit for the purpose of authorizing and regulating installation of sump pumps for the purpose of discharging accumulated seepage water from basement and crawl areas; and setting forth penalties for the violation of the provisions of this ordinance.

**SECTION II**

**PROVISION FOR SUMP PUMP DISCHARGE  
INTO PLSD COLLECTION SYSTEM**

To connect a sump pump for removal of accumulated seepage water from basement and crawl space areas, the property owner shall agree to and comply with the following provisions:

- A. Accumulated seepage water from basement and crawl space areas may only be discharged into the PLSD collection system after making application to the District Manager and receiving a Permit to do so.
- B. The Sump Pump Discharge Permit shall authorize the discharge of basement and crawl space seepage waters into the PLSD collection system from November 1 to April 1 of each calendar year. Basement and crawl space seepage waters SHALL NOT BE discharged into

the PLSD Collection System during the period April 1 to November 1.

- C. The Sump Pump Discharge Permit shall be in continual effect after issuance so long as the property owner complies with the provisions of this and other PLSD Ordinances, or until such time as this Ordinance is amended or rescinded.
- D. The Sump Pump Discharge Permit shall be issued to the property owner without a financial charge. The property for which the Permit has been issued will be assessed the Operation and Maintenance Fee based on the annual assessment amount (12 month usage).

### SECTION III

#### VIOLATIONS AND PENALTIES

Discharge of accumulated surface water and seepage water into the PLSD collection system is authorized only by the issuance of the Sump Pump Discharge Permit.

- A. Property owners that discharge surface or seepage waters into the PLSD collection system without a valid Sump Pump Discharge Permit shall be subject to a \$500.00 violation assessment and an additional assessment in the amount of \$100.00 per day of violation for each day after five (5) days of mailing the notice of violation by First Class Mail to the address on record in the Sanitary District files if the violating circumstances are not corrected.
- B. Property owners in possession of a Sump Pump Discharge Permit that discharge surface or seepage waters into the PLSD collection system beyond Permit's specified limitations and/or restrictions shall be subject to a \$300.00 violation assessment and an additional assessment in the amount of \$100.00 per day of violation for each day after five (5) days of mailing the notice of violation by First Class Mail to the address on record in the Sanitary District files if the violating circumstances are not corrected.

## SECTION IV

### INSPECTION AND ENFORCEMENT

- A. Property in violation of the provisions of this Ordinance shall be subject to inspection for compliance purposes by Maintenance Employees, Members of the Board of Trustees, and/or the District Manager. Upon presentation of proper identification and/or personal recognition the above identified persons shall be authorized to make such inquiry and investigation for compliance with this Ordinance without the need of other legal documentation.
- B. Refusal of the Property Owner to permit and authorize such inquiry and investigation shall be interpreted as an indication of violation of the terms of this Ordinance and penalty as Identified in Section III shall be assessed.
- C. Penalties for violations assessed under the terms of this Ordinance shall be subject to the same Delinquent Payment Terms of other assessments of the PLSD.

## SECTION V

### VALIDITY

All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

The invalidity of any section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts thereof..

SECTION VI

ORDINANCE IN FORCE

This Ordinance shall be in full force and effect from and after its passage, approval, recording,

and publication as provided by law.

# SUMP PUMP AUTHORIZATION APPLICATION

I, the undersigned owner/occupant of property located within the boundaries of Pickerel Lake

do, herewith, make application for a Sump Pump Connection to Pickerel Lake Sanitary District's Collection System under the provisions of Pickerel Lake Sanitary District Ordinance No. 13.

I understand that the provisions of Ordinance No. 13 provide for sump pump discharge into the Sewer Collection System during the calendar period November 1 to April 1 and is not authorized during the period April 1 to November 1. I further understand that penalty for violating the provisions as provided in Ordinance No. 13 with a Sump Pump Permit is an assessment in the amount of \$300.00 per violation and an additional assessment of \$100.00 per day of violation for each day after five (5) days of the notice of violation. Violators not in possession of a Sump Pump Permit shall be assessed a penalty in the amount of \$500.00 per violation and an additional assessment of \$100.00 per day of violation for each day after five (5) days of the notice of violation.

All holders of a Sump Pump Permit will be billed for Operation and Maintenance Costs on a semi-annual basis (March 1 and September 1) based on the full time assessment for each calendar year.
