

**PICKEREL LAKE SANITARY DISTRICT**

**ORDINANCE NO. 3**

AN ORDINANCE in and for Pickerel Lake Sanitary District, Day County, South Dakota, amending Ordinance No. 2, Section 2, with reference to the dates when connection fees shall be paid.

BE IT ORDAINED AND ENACTED by the Board of Trustees of Pickerel Lake Sanitary District, Day County, South Dakota, as follows:

**SECTION 1**

That Section 2 of Ordinance No. 2 be repealed and re-enacted as follows:

**SECTION 2**

**PROPERTY OWNER CONNECTION FEES**

The property owner shall pay a connection fee to the District as follows:

A. Residential User:

- (1) \$1,000.00 if paid \$500.00 before August 1, 1995, and \$500.00 before November 1, 1995.
- (2) \$1,500.00 if paid on or after November 1, 1995.

B. Non-residential User:

- (1) \$1,000.00, if paid \$500.00 before August 1, 1995, and \$500.00 before November 1, 1995.
- (2) \$1,500.00, if paid on or after November 1, 1995.

All connection fees remaining unpaid after January 1, 1996, shall be considered delinquent and shall be certified to the County Auditor in accordance with SDCL 34A-5-40.

SECTION 3

ORDINANCE IN FORCE


